

## REGULATIONS FOR USING THE APARTMENT

Dear guests,

Welcome to our apartments in Rewal.

We hope that You will feel here as comfortable as in your own home.

Please respect the following regulations:

1. Please take care of the facility in which you are staying and leave it in the condition in which you would like to find it.
2. The accommodation day begins at **4:00 pm** on the day of arrival and ends at **11:00 am** on the day of departure.
3. It is possible to adjust the hours with the consent of both parties, provided that they do not conflict with other reservations.
4. It is possible to extend the night of accommodation, provided that the request is made to the Lessor by phone by 10:00 am on the day preceding the departure. The landlord will take into account the request as there are free apartments available.
5. **Extending the stay costs 50% of the basic rate and lasts up to 7.00 p.m. Staying in the apartment after 19:00** is automatically treated as an extension of the day of stay.
6. There is a curfew from **22:00 to 7:00**.
7. The number of people staying in the apartment given at the time of booking may not be exceeded. If the number of people is exceeded, we reserve the right to charge additional fees for the stay of additional guests **in the amount of PLN 100 per person per night**.
8. The Lessor may invite guests to the Apartment area before prior notice and with the consent of the owners.
9. **Additional guests may stay on the premises until 21.00**, after this time the payment for the stay of the additional guest will be automatically charged - **PLN 100 per person per night**.
10. Please use the furniture in accordance with its intended use and put it back in its place.
11. **Smoking is absolutely forbidden in the house**. For the safety of guests, a smoke detector is installed in the house, in the event of smoke detection, the SOLID intervention group will appear to verify that there is no fire risk.
12. Please use electrical devices in accordance with their intended use and read the operating instructions before using them.
13. We love animals - however, we ask that the pets staying with us be under the watchful eye of their guardians (not to stay on the sofas, etc.). The owner is obliged to cleaning up after their pet inside the house and on the terrace, as well as in the garden and housing estate. Tenants take full responsibility for it when they are in the facility.
14. The fee for a dog's stay is **PLN 20 per night - for each dog**.

15. In the case of renting guests, if they stay at the facility after At 21.00, the fee for a dog is **PLN 20 per night if they are with a dog.**
16. **THE USE OF ADDITIONAL SERVICES ON THE ORANGE TV PLATFORM IS FORBIDDEN.** If there is a use of additional TV services (purchase of a movie, access to NETFLIX service, etc.), it will be additionally payable and the customer will be charged with costs. They will be taken from your deposit.
17. In the event of damage suffered by persons staying in the facility (bodily injury, theft of guests' property, etc.), you should inform your insurer, the owner is not responsible for any personal or property damage.
18. Please report any damage to the facility or equipment immediately. The current tenants are responsible for any damage caused to the facility or its premises.
19. For the loss of a set of house keys (gate remote control, door key), we charge an additional fee of PLN 500 for each lost item.
20. A refundable deposit of PLN 400 is obligatory.
